#### COMMISSIONED RULING ELDER PROGRAM (CRE)

Our church session is in discussion with Jonathan Kimball about his serving our church parttime as a CRE. If you are not familiar with the term, the following information from the PCUSA is a good introduction.

What is a Commissioned Ruling Elder (CRE)? A CRE is an elder in the Presbyterian Church (USA) who is granted a local commission by the presbytery to limited pastoral service as assigned by the presbytery.

Who commissions the ruling elder? When the presbytery is satisfied with the qualifications of a ruling elder to serve a congregation, it shall commission the ruling elder to pastoral service as designated by the presbytery.

What is the ruling elder commissioned to do? A commissioned ruling elder is responsible to watch over the people and provide for their worship and nurture. Permission for specific activities will be included in the approval of the Committee on Ministry.

Why commission Ruling Elders? We believe that God's Spirit provides opportunities for new forms of ministry to build up Christ's Church. Baptized Christians who are ordained as Ruling Elders may bring particular gifts to share in discernment of God's Spirit and governance of God's people.

What is the CRE application process? A CRE must be a Ruling Elder in the PC(USA); Must be endorsed by home church; Must submit application for approval by the Committee on Ministry; Must complete a psychological evaluation administered by LeaderWise.

Who certifies a CRE candidate as prepared to be and suitable for the role of CRE? The Committee on Ministry (COM) interviews, reviews application, determines what training is required, and certifies to the presbytery that a candidate is ready to serve as a CRE.

What training is required? A ruling elder who seeks to serve as a Commissioned Ruling Elder shall receive such preparation and instruction as determined by the presbytery. (G-2.1001-2.1004)

How is a CRE compensated? A Commissioned Ruling Elder shall receive compensation in accordance with the presbytery's Compensation and Personnel Policy for Pastors.

The Committee on Ministry requires the following areas of training for CRE candidates. The training for each CRE candidate shall be overseen and administered by COM. • Biblical Studies • Reformed Theology and Sacraments • Presbyterian Polity • Preaching • Leading Worship (including administering sacraments when authorized) • Pastoral Care • Field Internship • Healthy Boundary Training

What is the process for examination and eligibility for ministry? • The Committee on Ministry is charged with conducting a background check and the examination of those it certifies as prepared to be and suitable for the role of Commissioned Ruling Elder.

What can the CRE be authorized by COM to do? A CRE can perform one or more of the following services:

Who supervises the CRE? The CRE shall work under the supervision of the Committee on Ministry. A minister of the Word and Sacrament shall be assigned as a mentor.

### Worship and Music

Worship and Music provides: liturgy and hymns, special music (thanks Jeff), preachers in the pulpit scheduled by Mary Kwantes, worship leaders as scheduled by Linda Rose, preparation of Worship Guides and PowerPoint provided by Jonathan, serving of communion the first Sunday of the month in the church and the 2nd Sunday at the Manor, also seasonal liturgical colors in the sanctuary plus planning of special services.

We held a regular communion service where elders passed the elements. We feel it went well. Please let any worship member know how you feel about any of these activities.

We experienced \$1500 repairs to sound and streaming equipment.

We are hoping to continue streaming, but all this equipment, including piano, and organs need repair and/or tuning. Please help us maintain all the services we now provide by giving generously in the next few months as air conditioning expenses kick in.

Ming has provided our minutes regularly to session.

Let us know if our worship meets your needs both in the sanctuary and at home.




The 2024 Per Capita for ecclesiastical expenses is based upon the membership of your church as reported to General Assembly on December 31, 2023.
